Ms. Linton introduced Joanne Jackson of Jackson-Brown Associates Inc. as the Project Manager and Cameron Burns of Shoalts and Zaback Architects Ltd. as the Architect for the project. Ms. Jackson outlined the lengthy approval process to date and advised that they hoped to be ready to go to tender in August, 2017 with construction commencing in October, 2017. The construction phase would be approximately four to six months. Mr. Burns provided an overview of the preliminary working drawings for the project and advised that a sound study would be undertaken to ensure that surrounding neighbours would not be adversely affected by the construction noise or the building operation noise following construction. He also mentioned that they would be meeting with all the neighbours in the area to keep them informed on the status of the project.

2. Maril Swan – Tweed Lions Tree Proposal.

Maril Swan was unable to attend the meeting as planned to present the Tweed Lions Tree Proposal but advised that she would reschedule the delegation to attend another meeting.
