


Photo 1: North Approach and Deck Top Looking South





Photo 3: East Exterior T-Beam, Fascia, and Barrier Wall





Photo 5: South Span Interior T-Beams and Soffit Looking North





 Photo 8: Scaling, Patching, and Spalling with Exposed Rebar on West Exterior T-Beam





Photo 11: Erosion and Undermining on Southeast Abutment Wall




Photo 13: Scaling on Interior Barrier Wall





Photo 1: Deck Top Looking South



Photo 3: Scaling and Cracking with Efflorescence on North Abutment Wall










Photo 9: Scaling and Cracking on Northeast Wingwall and Bulging on Retaining Wall




Photo 11: Delamination on North Span Soffit






Photo 13: Scaling and Scaling on East Interior Barrier Wall






