



## **Skilled Trades Forum**

On March 7, 2019 the BR&E Committee held a Skilled Trades Forum. Local tradespeople were invited to attend and provide their input and insight. The evening started with a piece of pie and a questionnaire. A facilitated discussion followed with 5 questions being discussed.

- Q1. What do you need the most?
- Q2. How can the community support you in your recruitment/retention efforts?
- Q3. What are your training needs for yourself/your staff?
- Q4. Why would I want to work for you? Stay working for you? What do you offer as an employer?
- Q5. How do we encourage youth skilled trades? What role can you play?

These 5 questions led to a very interesting discussion, and some valuable insight into what we as a committee can do to help. A Skilled Trades Task Force is being implemented, with their goal to take these insights and make them a reality.

In addition to the survey for the tradespeople we created one for our residents/consumers. It has been brought to our attention multiple times that there are some struggles finding someone locally to complete work. The resident survey is still open as we are hoping for as much input as possible to assist with the development of our recommendations. # **Community Improvement Plan**



The Façade Improvement Grant/Loan is designed to encourage aesthetic improvements to commercial building exteriors.

### **Eligible Costs**

### Restoration, repair or replacement

- 1. brickwork, wood, masonry and metal cladding
- windows & doors
- 3. signage
- 4. exterior lighting
- 5. awnings, marquees and canopies
- redesigned shop fronts
- eaves, parapets & other architectural details
- professional fees

### **Eligibility Criteria**

Must adhere to general program requirements outlined in Section 5.1 & general application requirements outlined in Section 5.7 Improvements shall generally

comply with the design guidelines in Section 6

Financial Details: The Municipality may cover 50% of construction costs to a maximum of \$2500 grant and/or \$2500 loan. All loans issued at 0% interest and payable over three years (36months) unless noted otherwise. The grant will be awarded upon completion of the The loan will be awarded once application approved.

# Municipality of Tweed Community Improvement Plan:



The Accessibility Grant and/or Loan is designed to assist businesses in improving the accessibility of their building in accordance with the Accessibility for Ontarians with Disabilities Act 2005.

#### **Eligible Costs**

- Installation of automatic doors Installation of wheelchair
- accessible ramps Widening of public entrance
- 4. Leveling or repair to pathways/accesses and stairs
- 5. Any combination of the above
- 6. Other pre-approved accessibility improvements

### Eligibility Criteria

- All general program requirements outlined in Section 5.1 and application requirements outlined in Section 5.7
- Only the commercial area of the property
- Improvements shall comply with the Accessibility of Ontarians with Disabilities Act,

Financial Details: The Municipality may cover 50% of construction costs to a maximum of \$2500 grant and/or \$2500 loan. All loans issued at 0% interest and payable over three years (36months) unless noted otherwise. The grant will be awarded upon completion of the work. The loan will be awarded once application approved.
