#### **PLANNING**

Rezoning Application ZA5/14; to rezone the land at Part Lot 9 & 10, Concession 6 in Hungerford Township was reviewed. The rezoning permits a 55 acre parcel of land to be rezoned from Special Recreational/Resort Commercial Holding (RRC-6-h) to Rural (RU). The portion of land zoned Environmental Protection and Floodplain will remain unchanged. A letter was received from the County of Hastings Planning Department in support of the by-law amendment. Council approved the rezoning application and passed By-Law 2015-04 to change the zoning of the land to Rural.

Rezoning Application ZA6/14; to rezone the land at Part of Park Lots 17&30 in Plan 157 located the village was reviewed. The rezoning permits a 1,998 square metres of land to be rezoned from Residential First Density (R1) to Special Residential First Density (R1-8). The rezoning is a condition of severance application B22/11 which will create a residential building lot in the village. A letter was received from the County of Hastings Planning Department and the Quinte Conservation Authority in support of the rezoning application. Council approved the rezoning application and passed By-Law 2015-15 to change the zoning of the land to Special Residential First Density (R1-8) zone.

<u>Severance Application B75/14</u>; was reviewed by Council and the following motion was passed in support of the application;

BE IT RESOLVED THAT the Council approve of Severance B75/14, owner Platanys Hardy, East Part Lot 25, Concession 6, in the Township of Hungerford subject to the following conditions:

- i.) All realty taxes be paid in full.
- ii.) Parkland fee is paid in the amount of \$500.00 for the severed lot.
- iii.) Public Works Manager is satisfied with entrance to the severed lot and with ditching and drainage along the severed lot.
- iv.) Severed lot is rezoned to Rural Residential (RR) and, in addition, the existing water course and low lying wet area on the severed lot be rezoned to Environmental Protection (EP).
- v.) Road widening is required along the severed lot to conform to 43 ft. from the centerline of the travelled roadway Marlbank Road. Carried.

1. Vicki McCulloch – report on the January 26<sup>th</sup> meeting – Stoco Lake Plan

Vicki McCulloch attended the meeting on behalf of the Friends of Stoco Lake (FOSL) to report on the community meeting held January 26<sup>th</sup> to discuss the Stoco Lake Plan initiative. Ms. McCulloch thanked the members of Council for attending the meeting. She reported that FOSL is in its early planning phase of the initiative and is hoping to develop a two year plan to present to Council as soon as possible. Councillor DeGenova volunteered to be Council's representative for the Stoco Lake Plan initiative and Mayor Albert offered to be the alternate.

2. Jean McDonnell – Central Hastings Support Network – presentation

Sally Gale attended the meeting on behalf of the Central Hastings Support Network Committee to present statistics on the Central Hastings Transit Program and advised that user numbers have increased this year by 13%. She expressed appreciation for the previous financial support from the Municipality and requested the same consideration be given in 2015. Ms. Gale outlined the program's funding sources and noted that the Provincial Gas Tax Rebate continues to be a main source of revenue.
