


MUNICIPALITY OF TWEED

Strategic Planning Process

Members of Council and senior staff met on August 4, 2016 to participate in a strategic planning exercise facilitated by Penny Sharman of Sharman Municipal Consulting. The participants completed a SWOT (Strengths, Weaknesses, Opportunities & Threats) analysis; identified the Municipality's decreasing and increasing pressures; developed a wish list of strategic actions and concluded the day by prioritizing that wish list.

The consultant met with the Personnel & Finance Committee on November 9, 2016 to review the results of the prioritization and to confirm the direction in which to proceed and was authorized to draft a preliminary framework for the Strategic Plan, which included such components as a vision statement, focus areas and strategic actions. The committee requested that the Vision Statement of the Municipality's Integrated Community Sustainability Plan be adopted as the Vision Statement for the Strategic Plan.

The draft plan was reviewed by Council on September 12, 2017.

The Strategic Plan was adopted by Council on September 26, 2017.

Introducing the Strategic Plan Components

The Strategic Plan for the Municipality of Tweed is divided into three areas which comprise the main elements of any good strategic plan.

<u>Vision</u> describes what the Municipality of Tweed is striving to become.

<u>Focus Areas</u> describe the key functions on which the Municipality of Tweed wants to focus.

<u>Strategic Actions</u> identifies the actions or accomplishments that will contribute to making those results happen.

COMMUNITY PROFILE

The Municipality of Tweed is an amalgamated municipality comprising the former Village of Tweed (the urban center) and the former Townships of Hungerford and Elzevir & Grimsthorpe. The Municipality was officially incorporated as of January 1, 1998 as a lower-tier Municipality within the County of Hastings two-tier governing system.

Tweed is a Municipality located half way between Toronto and Ottawa, in the centraleastern part of Ontario, in the County of Hastings. The Tweed urban center is located approximately 40 km north of Belleville on Highway 37. The Hamlets of Marlbank, Stoco and Thomasburg are located south of the urban center, Sulphide is located east of the urban center and the other two Hamlets, Actinolite and Queensborough, are north of the urban center.

As the Gateway to the Land O Lakes and the Bay of Quinte Region, the area has become known for its small-town friendliness, affordability, accessibility, beautiful environment, outdoor recreational experiences, and annual events.

Approximately 30% of the population resides in the urban center. The remainder of the municipality consists of six Hamlets (Actinolite, Marlbank, Queensborough, Stoco, Sulphide and Thomasburg) and a large rural area which reaches from Wadsworth Lake in the north to Roslin in the south. The residents of the Hamlets and the rural areas comprise the other 70% of the population. The Municipality has a population of approximately 6,057and 3,160 households. There were 5,860 qualified electors in the 2014 election.

The total land area is approximately 230,000 acres (930 km²), 30% of which is Crown Land. Lakes, rivers and streams account for approximately 4,650 acres (18 m²).

The Black River joins the Moira River north of the Village of Tweed and meanders through the Village as the Moira River to empty into Stoco Lake and continues south to Belleville and the Bay of Quinte.

Tweed has an abundance of "Our Backyard" experiences like the North America's smallest jailhouse, world-class muskie/black crappie fishing on Stoco Lake, winery, culture, the Tweed Heritage Centre, hiking, and great events such as the Tweed

Tribute to Elvis Festival, the Tweed Stampede & Jamboree, the Festival of Trees, Art in the Park, Tweed & Area Studio Tour, and Feast from Farm.


Role of Council

The Municipality of Tweed is governed by a fivemember council comprised of a Mayor, Deputy Mayor and three Councillors.

The Municipality budgeted for over \$9,000,000 in gross expenditures for 2017.

Council meets twice monthly and attends adhoc

meetings, including meetings with outside agencies in which council represents the Municipality.

Economic and Development Trends

As stated previously, the Municipality is comprised of the Urban Centre and six Hamlets. Since the Village is the Municipality's only Urban Centre, it is considered the hub of the Municipality. The Municipality's business directory has a listing of 42 categories with a total of 368 businesses, organizations, community facilities or activities. Of these 368 listings, there are 262 commercial businesses under 35 different categories. The different categories demonstrate a broad and diverse range of business interests that can survive in this small but thriving Municipality.

The remaining 106 listings fall under various categories such as Attractions & Entertainment; Churches; Facility Rentals & Halls; Major Services; Municipal Facilities; Organizations and Public Service. The major employer is retail. There are a number of residents that commute to larger centres, primarily Belleville, for employment.

There is a strong sense of community in this Municipality, which is home to a number of active and dedicated service clubs such as the Kiwanis Club of Tweed and Lions Club of Tweed, a number of strong volunteer organizations and outstanding individuals.

Administration

Corporate Services is responsible for most of the administrative duties of the Municipality including municipal treasury; accounting; budgeting; reporting; tax collection; record keeping and management; preparing Council agendas and minutes; municipal elections; human resources; development of policies; implementing Council direction and initiatives; website management; communications; and by-laws.

Environmental Services

There are two Waste Disposal Sites and a Recycling Depot in the Municipality. Tweed implemented the clear bag policy and measuring the weight of bulk items in order to ensure a sustainable landfill for years to come.

Recycling, commercial recycling, household hazardous waste collection, and waste electronics collection is provided by Quinte Waste Solutions. Quinte Waste Solutions is

the operating name of the Centre & South Hastings Waste Services Board which provides these services for the 9 municipal partners that make up the Board.

The amounts of funding municipalities receive from Industry Funding Organizations is based on tonnages collected from the previous year reported to Waste Diversion Ontario.



Public Works

Roads & Bridges

The Municipality is responsible for 32 kilometres of rural asphalt roads; 15 kilometres of urban asphalt roads; 165 kilometres of tar and chip roads; 470 kilometres of gravel roads and 52 bridges. The arterial roads are Marlbank Road, Crookston Road and Quin-mo-Lac Road.

Water & Sewer

The Village of Tweed is serviced by a water and sewer system consisting of two pumping stations, one water tower, 8 km of water and sewer lines, and two lagoons. A high priority as identified in the Municipal Asset Management Plan is the development of a third lagoon. Currently the two lagoon system is operating close to capacity and, in order to facilitate further urban development, a third lagoon cell is required.

Building and Planning

Building Inspection for the Municipality of Tweed, Township of Stirling-Rawdon, Township of Tyendinaga, Town of Deseronto and Township of Madoc is administered by the Building Inspection Services Board.

The County of Hastings is the approval authority for consents and subdivisions and zoning amendments and minor variances are approved by the Municipality.

Recreation

There is an abundance of recreational facilities and opportunities in the Municipality to meet the local needs. A number of recreational activities are coordinated by volunteer

run organizations and partially funded by sponsorships.

CONSTRUCTION OF THE PARTY OF TH

The Tweed-Hungerford Community Centre, which is the home of Tweed Minor Hockey and the Tweed Figure Skating Club, is a municipally owned and operated facility.

The new Tweed Public Library, which opened in 2011, offers free

membership to all Municipality of Tweed residents and ratepayers. The library features core reference materials, books, meeting rooms, early literacy workstations computer and internet access, an online catalogue and resources, and assistance along the way. In addition, free Internet and WiFi is available to members and visitors and various programming from youth to seniors.



The Erin Palmateer Community Pool is a result of ten years of community fundraising. During the summer months the pool is operated by the YMCA of Central East Ontario. The Emily Trudeau Splash Pad was another community fundraising project with construction completed in 2015 and, prior to both projects, the John DeVries Soccer Field was created. Each project bound the community together with unwavering support to create legacy projects which will be enjoyed by multiple generations.

The Tweed Heritage Centre is an ever growing staple in the preservation of the history of the community. The Heritage Centre is governed by the Tweed & Area Historical Society which is driven by a group of dedicated volunteers.

The Land O'Lakes Curling Club is a not-for-profit organization governed by a volunteer Board of Directors. In addition to curling, the club offers pickle ball and shuffle board, along with other events in the summer months.

In the Hamlets, there are also three community halls that host various community events and are also available for rent. Key events in the Hamlets include M.A.C.K. (kayaking) Fest, chainsaw competition, theatre productions, community dinners and historic commemorative days.

In addition to the facilities referenced above, there are also seven conservation areas or parks located in the Municipality which are open to the public.

<u>Protective Services</u> <u>Fire Protection and Prevention</u>

The Fire Department Administration is a shared service with the Township of Stirling-Rawdon and consists of two paid employees, the Fire Chief and the Fire Prevention Officer and a group of dedicated volunteer firefighters. Each volunteer fire department are independent. There is one fire hall located in the Municipality.

Ambulance Service

The County of Hastings provides ambulance services. There is a satellite base, which operates during daytime hours, located in the firehall.

Policing

Policing is provided by the Central Hastings Ontario Provincial Police.

By-law Enforcement

By-law enforcement is carried out by a contract employee.

Implementing and Monitoring the Strategic Plan

Appendix 1 – Evaluation Criteria and Monitoring Mechanisms to Achieve Specific Goals and Implement the Strategic Plan – is a table that basically describes who is responsible for doing what, how is it going to be done, and when will it be done. Reference to and following Appendix 1 is pivotal to the monitoring and implementation of the Strategic Plan.

Annual budget reports as well as quarterly capital reports to Council will ensure that Council is informed on an ongoing basis that implementation of the Plan is either on track or that amendments are needed.
